

Paid Licence Terms and Conditions

1. If you have a paid license from us you bought, then you will have to check with what purchase you took from our site and see what you will have access too.
2. If you have purchased our **Edit My Video** subscription or for short **Extromnia Studios EMV (ESSEMV)**, you are given access to our team professionally editing your videos for you at a given price.
3. We cannot tell you exactly how much your music or song selection will cost, as it may vary per song or music, as different artists will charge a different price per music or song. But we can give you an estimated price based on the average price of a collection of previous songs bought by us.
4. You will know that the purchases of music or songs you make from us are all hassle-free as we take the effort to get them for you. These music or songs you get are for you to freely use in any of your video creations, but you must remember to state somewhere to show you have a license from us to use the music or songs so that they can check with us to confirm.
5. We will charge you 100% over the actual cost of the music or songs. If you have a valid coupon, you may use it. If you have a subscription, this may be a ton cheaper rather than paying it in one slip.
6. Please bear in mind that in paid memberships, not all features are unlocked as you will have to go up to a higher subscription option to have them unlocked, but essential options for that particular subscription are unlocked.

1. You can send anything into our cloud service.
2. We do allow for anything to be sent into our cloud, but if it is inappropriate, we will not accept it and we will discard it as being junk.
3. Inappropriate things may include but it is not limited to, *porn, nudes, racial discrimination, political discrimination, harassment and abuse, gore, etc...*
4. If you are a customer with us or a school, and you have a valid subscription with us, then it is okay for you to include copyright music in your content, as long as you wait till we approve and conclude if that the music or song is okay for use publically.
5. You are not allowed to include video footage on motion imagery of movies or shows as these are copyright protected, and it is outside our control to use this kind of content.
6. Do not send in recorded footage of one's YouTube videos without their approval, you must give proof to us that they have given you their approval to use their content. If they have already stated that it is okay to use their content, please send us the link to where they have put that statement in place.
